

- Clear and unambiguous
- Concise
- Clarity of thoughts
- Applicability of Provision
- Documents and information attached



#### Nature and grounds in various matters

#### Instances of some applications:

- □ Rule 11 application or even S 60(5) application
- Section 19 application
- Appointment of RP or change of RP
- Application for preferential transactions / undervalued transaction / transaction defrauding creditors
- Submission of Resolution Plan S 30



# Issues in drafting of applications in Chapter III

- □ \$ 43 to. \$ 51
- For instance
- S. 43 preferential transaction app and time frame
- For Corporate Debtor
- Time frame 2 yrs RP / 1 yr otherwise
- There is a transfer of property or interest of CD / benefit of creditor or surety or guarantee
- For any FC/OC or other liabilities owed by CD and
- ➤ Transfer has put the above in beneficial position vis a vis \$ 53

Ch III. Contd.

- Exceptions also their in ss (3)
- Provision is clear & unambiguous
- Not everything can be covered
- Different provision / different scope
- While drafting specific default / extent / time
  period / information / parties / documents & relief

## NCLAT - Appellate Tribunal

- □ Appeal u/s 61 of the Code
- Appellate Tribunal not a fact funding authority
- Question of law needs to be crystallised, not all issues can be taken up
- Segregation of issues is required to be made
- One needs to be always prepared before AT as no further opportunity can be granted
- Interim / final order challenged needs to be considered before AT
